

Ground Handling Charges - Canada



Effective March 30, 2008

Air Waybill Amendment Fee (CCA)

\$25.00 charged on any changes to the air waybill (including rate, surcharge, volume, weight, destination, consignee, or commodity).

Air Waybill Preparation Fee

\$20.00 per consignment (inclusive of shipper's export declaration if required).

Bank Hold Fee (for Bank Releases)

\$55.00 per consignment.

BIP Charges

Products of animal origin with a transit time of 12 hours or more in the UK are subject to a veterinary check and Border Inspection Post (BIP) Charges. Please check with us at time of booking.

Certified Manifest/Air Waybill Fee

\$20.00 per manifest/air waybill.

Charges Collect Fee

Minimum of \$20.00 -- or -- 5% of the weight and valuation charge, whichever is greater.

Dangerous Goods Fee

Minimum \$65.00 per UN number/ Minimum \$25.00 per ID. "For dangerous goods in excepted quantities & radioactive Materials in excepted packages."

Disbursement Charges

\$32.50 minimum charge per air waybill - or - 10% of the disbursement amount, whichever is greater. The same charge will be assessed for the collection of advance charges from the consignee for services performed prior to air transportation except for:

- Disbursement amounts less than \$50.00 in which case an \$8.00 charge will be assessed.
- Air freight charges are less than \$100.00 in which case disbursement amounts up to \$100.00 are permitted. This overrides the general rule of the disbursement amount not exceeding the air freight charge.

Import Service Charge

(Consolidation Breakdowns)

\$22.00 per Master Air Waybill plus \$20.00 per House Air Waybill .

\$22.00 only for back-to-back consolidations or consolidations delivered on a Master Air Waybill.

Live Animal Special Handling Fee

Minimum freight charge \$350.00. Export Live Fee \$55.00. Air waybill preparation fee of \$25.00. LHR/LGW Import Handling Charge of \$250.00 per consignment held up to 48 hours; fee is collected upon delivery in the UK. LHR/LGW ARC Transit Fee of \$250.00 per consignment collected upon departure from Canada.

Pets With Passports Fee

Applies to domestic cats & dogs/ UK terminating only/Not available into other UK destinations.

PTS charge of \$685.00 is inclusive of Export (including \$25 preparation fee) and Import fees. Each additional animal traveling from the same household on the same AWB is charged \$475.00.

Post Entry Fee

\$20.00 per post entry plus \$25.00 for the first piece plus \$5.00 per each additional piece.

Unit Load Device Handling Charges (Breakdown and/or recontouring)

IATA Type 8 \$75.00
IATA Type 6 \$150.00
IATA Type 5 \$250.00
IATA Type 2 \$300.00

Valuables (VAL) Security Handling Fee

Imports & Exports \$55.00. There is an additional fee of \$150.00 if transferring between LHR/LGW.

Storage Charges

Charges are applied to freight not collected 48 hours after aircraft arrival, excluding Sundays and Government holidays.
Min. \$30.00

▪ \$0.18 per kg per day or fraction thereof, but not less than \$7.50 per day per shipment based on volume weight with a minimum charge of \$30.00

▪ Special Handling Cargo - VAL AVI PER HUM VUN \$0.36 per kg per day or fraction thereof, but not less than \$30.00 per day per shipment based on volume weight with a minimum charge of \$60.00.

Terms & Conditions

All charges should be applied in CAD.

Other charges may be applied to reflect fees paid to governments, airports or other bodies of authority, e.g. NAVCAN in Canada.

Rates and NAVCAN will be applied to the chargeable weight of a consignment.

Any incidental charges incurred by British Airways or British Airways World Cargo on a consignment may be assessed against the agent and/or consignee.
