



## **Ground Handling Charges United Kingdom**

Effective from 02 September 2007

The following charges are minimum rates. Charges may be increased according to any extra time, work or expense involved and are subject to alteration without notice

1. All charges will be levied at the chargeable weight of a consignment.
2. Any incidental charges incurred by British Airways on a consignment may be passed on to the Agent/Consignee.

## EXPORT CHARGES

Charges are levied for processing, handling and warehousing of cargo up to the point of delivery to the aircraft, excluding airfreight charges, and are mandatory.
